## **Beginning Farmers and Ranchers**

- Are those who are new to farming or ranching. (Less than ten years experience)
- 30% of Farmers are Beginning Farmers
- Beginning farmers face significant barriers to entry into agriculture and unique challenges such as:
  - Land Access
  - Access to capital
  - Lack of experience
  - Less financial resilience
  - Less likely to be aware of USDA programs





# Types of Producers:

- "Thinking about farming" doesn't have a plan, land, capital, a market etc. and calls USDA wanting to know where to start
- Early in farming career—actively farming but needs support or funding
- More experienced BFR—ready to scale or expand
- Multigenerational—taking over the family business

New to farming? Want to learn how to start a farm? USDA offers dedicated help to beginning farmers and ranchers. USDA considers anyone who has operated a farm or ranch for less than ten years to be a beginning farmer or rancher.

USDA can help you get started or grow your operation through a variety of programs and services, from farm loans to crop insurance, and conservation programs to disaster assistance.

## Field facing agencies:



Farm Service Agency: provides disaster assistance, safety net, farm loan, and conservation programs and is the go-to agency for many USDA records.



Natural Resource Conservation Service: provides financial and technical assistance and easement programs for conservation on working lands.



Risk Management Agency: administers federal crop insurance through Approved Insurance Providers to help farmers prepare for the future.



Rural Development: provides loans, grants, loan guarantees, and technical assistance, along with support for affordable housing, infrastructure modernization, businesses, cooperatives, and other essential community services.
